EASY4Rust is designed to remove rust stains from delicate surfaces when other rust removers cannot be used due to their corrosive nature.

Efficient at removing rust and oxidisation from all natural stone including marble, granite and slate (Slate bleeding). Also removes rust and oxidisation from wood, paint, fiberglass and concrete.

Features & Benefits

- Non-acid formula converts rust compounds into water soluble solution
- Just needs to be washed away with clean water
- It does not alter the colour or look of the landscaped surface
- Environmentally friendly

APPLICATION:

- SHAKE THE CONTAINER FOR 30 SECONDS BEFORE EACH USE
- USE NEAT AS SUPPLIED
- Area must be dry
- Apply directly to the surface
- Agitate with a brush
- Product will turn dark purple on contact with rust
- Leave for a maximum of 20 minutes (if left longer, a dark stain may
- Rinse well with clean running water
- A slight residue may remain, this will fade away over the following 48 hours
- Repeat process as required
- Product will not harm plants when diluted



Precautions

- · Always test on a small hidden portion of the surface to be cleaned to check compatibility and performance before commencing on the whole area
- Do not use on previously treated or painted surfaces
- Surface should be clean, dry, and free from mould, algae, and efflorescence before applying. If the surface has been cleaned prior to application, all traces of the cleaner must be removed with a pressure washer, as remaining residue could render the surface impermeable
- Ensure the paving is completely dry prior to, throughout, and after application
- Keep children and pets/animals away until process is complete and surface is dry
- Ideal operating temperature between 10°C and 20°C. As a guide, ensure the surface is cool to touch
- . Do not apply in damp/wet conditions or if rain is expected within 48 hours of application
- Do not apply during frost or when temperature is below 5°C

Storage

- Keep container tightly closed
- 24 months in un-opened container at 20°C
- Do not store or display below 5°C
- Keep out of direct sunlight and protect from frost
- Keep out of reach of children

Health & Safety

- Harmful if swallowed
- Causes skin irritation
- Causes serious eye irritation
- Wash hands thoroughly after handling
- Use only outdoors or in a well-ventilated area
- Wear protective gloves/protective clothing/eye protection/face protection
- IF ON SKIN: Gently wash with plenty of soap and water. Take off contaminated clothing and wash before reuse. If skin irritation or rash occurs seek medical advice/attention
- IF IN EYES: Bathe the eye with running water for 15 minutes. Promptly wash eyes with plenty of water while lifting the eye lids. Continue to rinse for at least 15 minutes and get medical attention. Remove contact lenses if possible and safe to do so
- IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Wash out mouth with water. If conscious, give half a litre of water to drink immediately. Transfer to hospital as soon as possible
